The St. Sava Camp Committee is very excited about the upcoming 2011 camp season. If your children are not campers Week 4, please come back and join us to for the annual Diocesan Day celebration and picnic on August 7, 2011.

This page contains vital information regarding the registration process. Please read all instructions carefully before proceeding with application— even if your child has attended camp in previous years, as some of our policies have changed. Page 3 contains information you should keep regarding Camp.

This year's camp season will begin with the first week on Sunday, July 10th and run for 4 consecutive weeks:

Pick-up of children is Saturday morning at 10:00 AM for Weeks 1 through 3

*****Information Regarding Physical Exams For All Children Attending Camp*** All children attending camp must submit prior to their arrival completed health forms signed by a physician. Pennsylvania State licensing requirements mandate that we have a completed physical for your child. Your child cannot be admitted without a physical signed by a medical professional. We will no longer accept physicals that are filled out by parents alone. Please do not disappoint your child by failing to provide the necessary medical information.**

All campers should be covered by their family policy. While St. Sava Camp/Shadeland will act as a guarantor, any cost incurred by the Camp in providing required medical treatment, i.e., doctor visits, prescriptions etc., will be billed to the parent or guardian.

Financial Assistance: We do not wish for camp to be out-of-reach for any child and family. We encourage anyone who faces a hardship to please notify us through your parish priest or by contacting us directly. We have and will continue to offer assistance to those families in need.

Payment of Fees: If all or part of your camp fee is being paid by your Church, an auxiliary organization, or a third-party, that amount must be paid when your child arrives at Camp. Regrettably, we cannot afford to wait for payment.

Canadian campers must submit with their deposit an additional \$8.00. This is a processing fee that we are being charged by our bank. All checks and money orders must be submitted in U.S. funds only.

Cancellation policy: We appreciate prompt notice if a camper must cancel. Cancellations before June 1 will receive a refund of your deposit. After June 1st, refunds may be requested in writing and will only be granted if a replacement for the open spot is found, except in cases of family emergency.

Parent Volunteers: Please complete the Volunteer Application and submit it with your child's application. Space is limited. We may not be able to accommodate every parent who wishes to attend.

While we want every child to experience summer camp at Shadeland, our space is limited to 76 campers per week. The demand for Camp is great. We encourage you to fill out the application completely and send it in without delay. Once your application is received, we will send an email confirmation.

Check-out time: Saturday at 10:00 AM (except Tammie Week).
Please be considerate of the Camp Staff and show up on time!
The Camp Staff needs time to prepare for the next group of campers.
- Visiting the camp:** Everyone is encouraged to visit camp and observe your child's activities. Camp office must be contacted prior to your visit to confirm date and time.
All visitors must sign in at the office and be issued a visitor's badge.

Clothes & Miscellaneous to pack:

- Bedding:** sleeping bag, two sheets, 2-3 blankets, pillow, and pillowcase
- Towels:** 3 Towels, 3 washcloths, 1 beach towel
- Toiletries:** comb, toothbrush, toothpaste, soap, shampoo, sun screen, deodorant
- Clothing:** sturdy jeans, sweatshirts, daily change of underwear, socks, other clothes (shorts, t-shirts, etc.) pajamas, and swimming suit (no two piece-- including tankini bathing suits for girls or bikini trunks for boys).
For boys: one pair of pants and suitable shirt for church services (jeans t-shirts, and tennis shoes are not acceptable!)
For girls: skirt and blouse, or dress (dresses and blouses should have sleeves; skirts and dresses should be knee length. **Nothing short**)
For Waldameer, please bring a swimming bag to pack a towel, swim sandals change of clothing for after the swim park and a wallet or change purse for spending money at the amusement park.
- Costumes:** **We are not responsible for locating and/or providing costumes during Tammie Week.**
- Misc:** fishing gear

**Please do not send valuables --jewelry, etc.-- with your child. We will not be responsible for their security.

Be assured that your child will be given plenty of snacks, so please limit the number of snacks your child brings (no beverages). Campers will be permitted to eat snacks only during free time in the afternoon and evening.

Extra spending money: The limit is \$25 per child.

Items not permitted at camp: Cars driven by campers, weapons, **cell phones**, ipods, or any personal electronic devices. Please do not send any beverages.

Camp fee: \$100 deposit with the application + \$100 balance = \$200.00 total for Week 1 or 2 or 3
\$100 deposit with application + \$125 balance = \$225.00 total for Week 4

Please fill out all sections of the Camper Registration Form. The consent and responsibility waiver must be signed in order for us to operate the camp program.

Shadeland Camp strictly prohibits alcoholic beverages, illegal drugs, tobacco (smoking, chewing, etc.), fireworks, or weapons of any kind. Any violation will result in immediate dismissal from camp.

PARENT/GUARDIAN AUTHORIZATIONS, PERMISSIONS AND AGREEMENT

This health history is correct and complete as far as I know. The person herein described has permission to engage in all camp activities except as noted. I hereby give permission to the camp to provide routine health care, administer over-the-counter medications, administer prescribed medications, and seek emergency medical treatment including ordering x-rays or routine tests.

I agree to the release of any records necessary for treatment, referral, billing, or insurance purposes. I give permission to the camp to arrange necessary related transportation for me/my child. In the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the camp to secure and administer treatment, including hospitalization, for the person named above. I understand that my insurance coverage for my child will be used as primary coverage in the event medical intervention is needed. I further understand that I will be responsible for expenses not covered by my insurance.

I understand all reasonable safety precautions will be taken at all times by St. Sava Camp/Shadeland and its agents during camp. I understand the possibility of unforeseen hazards and know the inherent possibility of risk. I agree not to hold the Serbian Orthodox Diocese of Eastern America, their clergy, the St. Sava Camp/Shadeland, its leaders, employees, and/or volunteers liable for damages, losses, disease, or injuries incurred by the subject of this form.

I hereby give my permission to take field trips while attending camp at St. Sava's Camp Shadeland, (Springboro) PA.

I agree that my child will abide by all the rules and guidelines set forth by St. Sava Camp/Shadeland for the safety and good health of the campers at camp. I also agree that if my child has to return home due to discipline violations, it will be at my own expense.

CAMP GUIDELINES AND REGULATIONS FOR PARENTS AND CAMPERS

Please note that this form must be read and signed by both the camper and the parent. Applications will not be considered if this form is not signed and returned.

1. Shadeland Camp strictly prohibits camper cars, alcoholic beverages, illegal drugs, tobacco products, fireworks, or weapons of any kind. If your child is found having any of the above, he/she will be sent home immediately.
2. Shadeland Camp is an Orthodox Christian Camp for youth. Thus, any inappropriate, violent/aggressive, or unchristian behavior may result in your child(ren) being sent home immediately; these behaviors include, but are not limited to:
 - Attacking or hitting another camper, counselor, camp worker, or camp director.
 - Inappropriate "touching" or fondling of another camper (male or female) or counselor.
 - Disrespectful behavior (swearing, cursing, yelling in anger, use of shaving cream, or other substances) shown toward campers, counselors, director or workers.
 - Leaving the barracks at night after "lights out" to sneak over to the other barracks (boys to girls or vice versa), whether your child is caught in the act or not.
 - Cell phones, ipods, radios, stereos, boom boxes, personal gaming devices are not allowed at Camp.
 - Disrespect shown during the Church services.
 - Theft of camp property.
 - Destruction of camp property (bunks, lockers, doors, shower fixtures, windows, etc.) will not be tolerated. This includes picnic Sunday. If your child(ren) are involved in any of this, you will be held financially responsible and your child(ren) will not be permitted back to Camp the following year.
 - Barracks should be kept neat and presentable by campers. Please stress to your child(ren) to be respectful of the camp property.

We reserved the right to search luggage, lockers and bed areas at any time.
